It advances learning and curiosity during out-of-school hours for pre-K through 12th-grade children in every school in Alabama's Fairfield City School System. HOPE provides education and enrichment services throughout the school year and during the summer. During the 2021-22 academic year, we reached 174 pre-K and elementary students and 39 middle and high-school students. The HOPE 2022 summer program served 56 elementary students. We provided children with homework assistance, physical fitness, cultural enrichment experiences, STEM activities, and service-learning opportunities, all in a safe and nurturing environment. We utilized certified teachers, community partners, volunteers, and professional vendors to deliver quality programming for HOPE students.
